Rule 25.06	<p>Rule 25.06 Notices</p> <p>(1) Notice to depositors: The service of any notices required pursuant to these Rules to be served on or sent to the depositor shall be deemed served if sent by ordinary post or left at the depositor's last known address as provided to the Depository by the depositor, and, if served by post shall be deemed to have been received at the time when the letter containing the notice would be delivered in the ordinary course of post. The service of any court process may also be effected by any manner permitted by law.</p>	<p>Rule 25.06 Notices</p> <p>(1) Notice to depositors: <u>Notwithstanding Rules 2.11 and 14.11, The service of any notices, statement of accounts or other communication from the Depository to the depositor required pursuant to these Rules to be served on or sent to the depositor may be given or sent using any one of the following modes, as the Depository deems fit:</u></p> <p>(a) <u>by hand to the depositor's last known address as provided by the depositor to the Depository;</u></p> <p>(b) <u>by ordinary post to the depositor's last known address as provided by the depositor to the Depository;</u></p> <p>(c) <u>by electronic means to the depositor's last known electronic contact details as provided by the depositor to the Depository or any other instantaneous means; or</u></p> <p>(d) <u>by any other means as the Depository may deem fit.</u></p> <p>(2) Notice to depositors (deemed service): <u>Any notice, statement of accounts or other communication shall be is deemed served upon and received by the depositor:</u></p> <p>(a) <u>if sent by hand, at the time of delivery;</u></p> <p>(b) <u>if sent by ordinary post, or left at the depositor's last known address as provided to the Depository by the depositor, and, if served by post shall be deemed to have been received at the time when the letter containing the notice, statement of accounts or other communication would be delivered in the ordinary course of post; and</u></p>

	<p>(2) Notice to Depository: The service of any notice or any court process to the Depository shall be addressed to its registered office at -</p> <p>6th Floor Exchange Square Bukit Kewangan 50200 Kuala Lumpur</p>	<p><u>(c) if sent by electronic or any other instantaneous means, on the same day as when the notice, statement of accounts or other communication was sent or effected by the Depository.</u></p> <p><u>(3) Additional mode of service in the manner permitted by law:</u> <u>Notwithstanding anything in these Rules, the service of any court process on a depositor may also be effected by any manner permitted by law.</u></p> <p><u>(24) Notice to Depository:</u> The service of aAny notice, <u>other communication</u> or any court process to <u>be served on or sent to</u> the Depository shall<u>must</u> be addressed to its registered office at:-</p> <p>6<u>15</u>th Floor Exchange Square Bukit Kewangan 50200 Kuala Lumpur.</p> <p><u>and unless the mode of delivery is otherwise specified by the Depository, must be delivered by hand, by courier or by post. Proof of posting is not proof of receipt and the Depository is deemed to have received such notice, other communication or court process only if receipt is acknowledged by the Depository.</u></p> <p><u>(5) Undelivered communication:</u> <u>The Depository may cease sending notices, statements of accounts or other communications to the depositor's address or contact details in the Depository's records if 5 of these communications are consecutively returned undelivered to the Depository. The Depository will resume sending notices, statements of accounts or other communications upon the address or contact details being updated by the depositor.</u></p>
