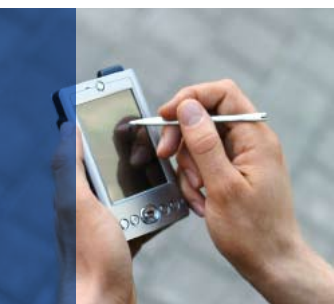
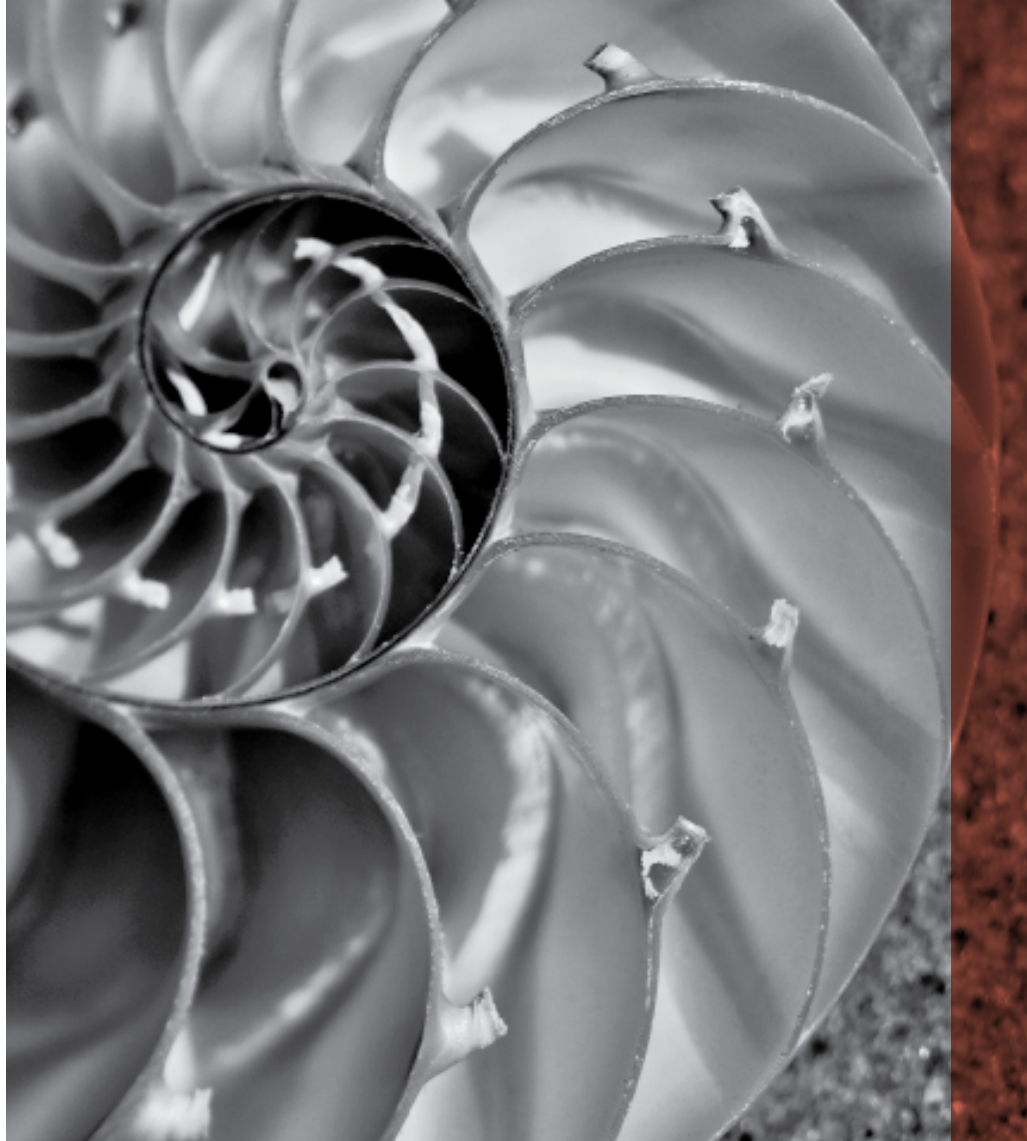

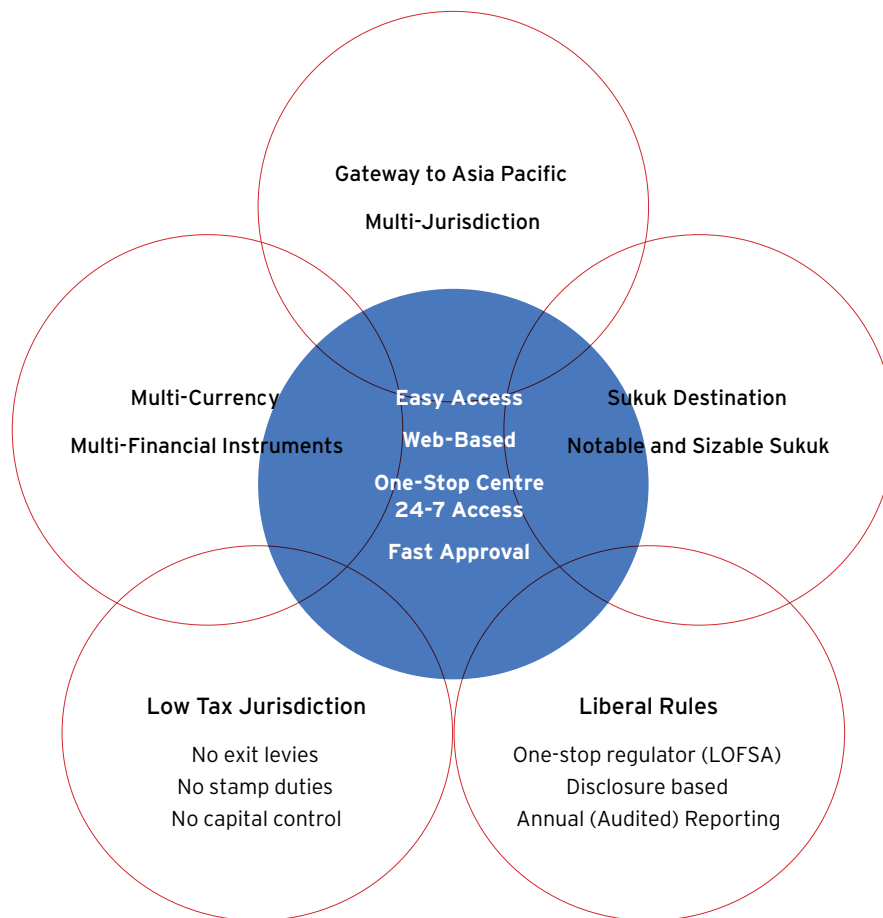


Labuan International Financial Exchange (LFX) was incorporated in Malaysia in July 1999 with an authorized capital of USD10 million and a current paid-up capital of USD5.5 million. It is a wholly owned subsidiary of Bursa Malaysia Berhad, the country's only stock exchange. It was established to complement the various financial services offered by Labuan International Business and Financial Centre (IBFC).

LFX shares the same regulator as Labuan IBFC which is Labuan Offshore Financial Services Authority (LOFSA), the statutory body that provides due diligence and governance according to internationally recognised laws and regulations.
