

## MONTHLY REPORT ON THE STATUS OF COMPANIES WHICH HAVE TRIGGERED A PN17/GN3 PRESCRIBED CRITERIA

The financial condition of a listed issuer on a consolidated basis must, in the opinion of Bursa Securities, warrant continued trading or listing on the Official List. A PN17 and GN3 Company must comply with the requirements under Paragraph 8.04 and PN17 of the Main Market Listing Requirements and Rule 8.04 and GN3 of the ACE Market Listing Requirements respectively, failing which Bursa Securities shall suspend the trading of the listed securities of such listed issuer or de-list it, or both.

As at 31 March 2021, there are a total of 21 companies classified under PN17 and GN3 which represent 2.34% of the total number of 899 companies listed on the Main Market and ACE Market of Bursa Securities. The status of these companies are set out in the table below.
